WHEREAS, the Frederick C. Joyce Elementary School in North Highlands is named in his honor; and

WHEREAS, Mr. Joyce represented District III on the Amador County Board of Supervisors from 1979-1983 serving as Chairman of the Board in 1980; and

WHEREAS, on February 5, 2008 Frederick C. Joyce, generously donated 80 acres currently known as Mollie Joyce Environmental Center to the Amador County Recreation Agency; and

WHEREAS, Mr. Joyce has always been a generous-supportive benefactor of the Community and is known for his incredible dedication and support of the Amador County Senior Center: Including weekly trips to Sacramento for See's Candy, planning weekly bus trips to Tahoe, meeting the Sysco truck to facilitate food delivery, among many other responsibilities; and

WHEREAS, Mr. Joyce's personal philosophy was "It is better to wear out than to rust out."
