WHEREAS, Mariposa County Board of Supervisors adopted Resolution Number 10-454 in September 2010, in which Mariposa County requested membership in the Agencies; and

WHEREAS, the governing Boards of the Agencies adopted Resolution Number 2010-1-A, which supports Mariposa County's membership in the Agencies and requested that the Members each pass a Resolution supporting the membership of Mariposa County in the Agencies and approves the Amendment of the Agencies' Joint Powers Agreements; and

WHEREAS, Section 14, entitled "Amendment", of the Joint Powers Agreement forming the Central Sierra Economic Development District states, "This Agreement may be amended at any time by the mutual written agreement of all the members thereof."; and

WHEREAS, Section 10, entitled "Amendment of Agreement," of the Agreement for the Formation of the Central Sierra Planning Council states, "This Agreement may be amended upon approval of two-thirds of the legislative bodies of member agencies."
