WHEREAS, the Board of Supervisors for the County of Amador has the authority to implement Government Code Section 20691; and

WHEREAS, the Board of Supervisors for the County of Amador had a written labor policy or agreement which specifically provided for the normal member contributions to be paid by the employer; and

WHEREAS, the Board of Supervisors for the County of Amador has renegotiated said policy or agreement and now has a written agreement that provides for a reduction in the amount of the normal member contributions to be paid by the employer; and

WHEREAS, one of the steps in the procedures to implement Section 20691 is the adoption by the governing body of the County of Amador of a Resolution relative to said Employer Paid Member Contributions (EPMC); and

WHEREAS, the Board of Supervisors for the County of Amador has identified the following conditions for the purpose of revising its election to pay EPMC:

- This revised benefit shall apply to the following Management Employees: Agricultural Commissioner/Air Pollution Control Officer, Chief Deputy Clerk/Recorder/Surveyor, Community Development Director, County Counsel, Chief Assistant District Attorney, General Services Administration Director, Health and Human Services Agency Director, Director of Health Services, Human Resources Director, Information Technology Director, Chief Probation Officer, Public Services Director, Undersheriff, and Veterans Services Officer. This revised benefit shall not apply to any other employees who are designated to receive the same pension benefits as Management Employees or to Elected Officials.

- This revised benefit shall consist of a reduction in the current EPMC as follows:

1. For the Undersheriff, the Chief Probation Officer, and the Chief Assistant District Attorney, the EPMC shall be reduced from nine percent (9%) to (i) six percent (6%) on April 1, 2011, and (ii) three percent (3%) on October 1, 2011; and
2. For all other Management Employees denominated above, the EPMC shall be reduced from seven percent (7%) to (i) four percent (4%) on April 1, 2011, and (ii) one percent (1%) on October 1, 2011.

- The effective date of this Resolution shall be April 1, 2011.


BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California that the County of Amador elects to pay EPMC as set forth in the last recital above.
