WHEREAS, on Saturday, the 30<sup>th</sup> day of April 2011, over 65,000 members of The Church of Jesus Christ of Latter-day Saints joined with other community volunteers for the annual Mormon Helping Hands Day in California and Hawaii; and

WHEREAS, the Jackson Ward of The Church of Jesus Christ of Latter-day Saints accomplished a substantial amount of restoration to the Kennedy Mine Project ; and

WHEREAS, the volunteers worked on all three floors of the Mine Office building and painted several doors including the two inside bathrooms and interior hallway; and

WHEREAS, the volunteers worked on the water tower and the ground-level wooden deck of the head frame were covered with Preserva-wood and large areas of weeds were cut; and

WHEREAS, the serious cracks in parts of the Change House north wall were filled by a mason and the bridge over the north fork of Jackson Creek, received major upgrading.

WHEREAS, the Ione Ward of the Church of Latter Day Saints worked at the Amador County Fairgrounds and accomplished the following:

- They provided rollers/brushes and the Fair provided drop cloths and paint to paint the Benny Brown arena bleachers.
- Installed two baby changing stations in the Mid Way Rest Room.
- Filled the many pot holes and ruts throughout the grounds that were left over from the heavy rains.
- Painted the patio area of the Windmill Restaurant.
- Repaired and replaced the rotten boards in the covered bridge by Pokerville Hall.
- Pulled weeds, clean and raked the flower beds down the Mid Way.
- Repaired and replaced the top handrail on the Benny Brown view stand.
- Cleaned out the debris in the waterfall behind Pokerville Hall.


