WHEREAS, pursuant to the provisions of Section 2922(e) of the Revenue and Taxation Code of the State of California, the Amador County Treasurer/Tax Collector may collect actual costs of collection incurred by the County up to the time an unsecured delinquency is paid; and,

WHEREAS, the Treasurer/Tax Collector has reviewed these actual costs of collection and has developed a fee schedule for recovering these costs;


