WHEREAS, the County of Amador ("County") has granted to ACES Waste Services, Inc. ("ACES") a franchise to collect solid waste in portions of the County; and

WHEREAS, pursuant to the franchise agreement the rates and charges imposed by ACES for collection of solid waste shall be set from time to time by resolution of the County's Board of Supervisors after public notice and public hearing; and

WHEREAS, as a condition of the ACES Land Use Permit, the County Board of Supervisors shall set the fees charged at The Pine Grove Transfer Station; and

WHEREAS, ACES has requested a rate increase for The Pine Grove Transfer Station as describe on Attachment A attached hereto; and

WHEREAS, the proposed increase in rates for The Pine Grove Transfer Station was reviewed, taking into account ACES' service to customers, performance of other duties required by franchise agreement, profitability, administrative costs, operational costs, capital costs, and other appropriate financial matters, and was found to be justifiable; and



The new rate schedule set forth in Attachment A shall be effective July 12, 2011 for The Pine Grove Transfer Station.
