AFTER 25 YEARS OF SERVICE WITH AMADOR COUNTY )**

WHEREAS, Glenn Douglas Humphries graduated from San Ramon Valley High School in June 1972, began his Law Enforcement career with the Contra Costa County Sheriff's Office in 1971 as a Cadet and Dispatcher, hired at the Rocklin Police Department as a Dispatcher in 1974, a Reserve Police Officer in 1975 and attended the Sacramento Law Enforcement Training Center, earning a California Basic POST Certificate on January 26, 1978; and

WHEREAS, early in his career, Glenn worked at the Placer County Sheriff's Office, Twin Cities Police Department and the California Exposition and State Fair Police. Glenn was hired as a Deputy Sheriff with the Amador County Sheriff's Office on May 29, 1987 and assigned to the Amador Calaveras Tuolumne Narcotics Enforcement Team from 1989 to 1992, the Investigations Division from 1992 to 1997, promoted to the rank of Sergeant in October 1997, promoted to the rank of Lieutenant in October 1999 and promoted to the rank of Captain in October 2002; and

WHEREAS, Glenn was assigned various collateral duties throughout his career including Driving Instructor; Field Training Officer; Investigator; Traffic Officer; Patrol Fleet Manager; and Boating and Waterways Coordinator and established and managed the Amador County Sheriff's Office Asset Forfeiture Program and was also instrumental in the seizure of hundreds of thousands of dollars in US Currency and numerous real properties from drug manufacturers and drug dealers; and

WHEREAS, Glenn was recognized in the local law enforcement community as an expert in drafting search warrants, seizure orders and administrative documents and a founding member of the Amador County Deputy Sheriff's Association and Sheriff's Office Mid-Management Unit and throughout his tenure he was instrumental in recommending and acquiring the most qualified employees, newest technologies and highest quality equipment for the Amador County Sheriff's Office, making the office a leader in regional law enforcement; and

WHEREAS, Glenn is the proud brother to Robert Humphries, who has followed in Glenn's law enforcement foot steps, and is a Sergeant at the Los Angeles Police Department, assigned to the Valley Division; and

WHEREAS, Glenn exemplified the Sheriff's Core Values of Service, Integrity, Teamwork and Excellence (S.I.T.E.) throughout his career at the Amador County Sheriff's Office; and

THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California, that said Board does hereby adopt this resolution commending Glenn Douglas Humphries for his many years of service to the people of the County of Amador.
