WHEREAS, Mark graduated from Wooster High School in Reno, Nevada in 1974; and

WHEREAS, Mark relocated to Amador County in 1975; and

WHEREAS, Mark married his beautiful wife Teri on July 13, 1985; and

WHEREAS, Mark and Teri have two wonderful children, Heather and Aaron; and

WHEREAS, Mark put himself through the Modesto Police Academy, graduating in the top three of his class in 1985; and

WHEREAS, Mark began his Law Enforcement career as a Police Officer with the Ione Police Department from May 1986 to December 1987; and

WHEREAS, Mark continued his career as a Police Officer with the Sutter Creek Police Department from January 1988 to April 1993; and

WHEREAS, Mark was honored by the Amador County Peace Officer's Association for performing life saving CPR on a one month old infant while employed by Sutter Creek Police Department; and

WHEREAS, Mark was hired as a Deputy with the Amador County Sheriff's Office on April 21, 1993 and has spent the past 17 years dedicated to serving and protecting the citizens of Amador County; and

WHEREAS, Mark was promoted to the Rank of Sergeant on January 12, 1998; and

WHEREAS, Mark has been assigned as a Detective Sergeant in the Investigations Bureau since 2001, where he has excelled in investigating crimes against persons, including robbery, homicide, elder abuse, sex crimes and child abuse; and

WHEREAS, Throughout Mark's Law Enforcement Career, he has fulfilled the duties of a Deputy Sheriff, Field Training Officer, SWAT Officer, Property Crimes Detective, Deputy Coroner, Patrol Sergeant and Sergeant in Investigations; and

WHEREAS, Mark also took part in the Community Policing Program and is the Founder of the Sheriff's Toy Drive that continues to be very successful; and
