WHEREAS, the County of Amador ("County") has granted to Amador Disposal Service/Waste Connections, Inc. ("ADS") a franchise to collect solid waste in portions of the County; and

WHEREAS, pursuant to the franchise agreement the rates and charges imposed by ADS for collection of solid waste shall be set from time to time by resolution of the County's Board of Supervisors after public notice and public hearing; and

WHEREAS, ADS has requested a rate increase for The Buena Vista Transfer Station as describe on Attachment A attached hereto; and

WHEREAS, the proposed increase in rates for The Buena Vista Transfer Station was reviewed, taking into account ADS' service to customers, performance of other duties required by franchise agreement, profitability, administrative costs, operational costs, capital costs, and other appropriate financial matters, and was found to be justifiable; and


NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California that said Board does hereby approve the rate increase request for The Buena Vista Transfer Station. The new rate schedule set forth in Attachment A shall be effective June 1, 2010 for The Buena Vista Transfer Station.

The foregoing resolution was duly passed and adopted by the Board of Supervisors of the County of Amador at a regular meeting thereof, held on the 25th day of May 2010 by the following vote:
