WHEREAS, Carol married her husband Duane in 1990; and

WHEREAS, Carol worked with retired Jail Commander, Emmett Rettagliata, up to one week before the due date of her second daughter. Carol would often grab her stomach pretending she was in labor, and Emmett fell for it several times; and

WHEREAS, Carol and Duane welcomed their daughter, Aimee, in 1992; and

WHEREAS, Carol promoted to Correctional Sergeant on January 1, 2003; and

WHEREAS, Carol has attended various training courses and maintained the Inmate Welfare Fund; and

WHEREAS, Carol is the proud Grandma of Michael and Cecilee, and looks forward to spending quality time with them; as well as traveling, volunteering in the County Archives Office and spending her summers at her mountain property; and

WHEREAS, Carol has expressed that her co-workers are like a second family to her. Carol's years in the jail have been a long and interesting journey. Carol has seen a lot changes at the Sheriff's Office over the years and is pleased to see the Agency moving forward in a positive direction where everyone works together as a team; and

THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Amador, State of California, that said Board does hereby adopt this resolution commending Carolyn Thelma Adamson for her many years of service to the people of the County of Amador.


