WHEREAS, the Woman's Club of Jackson was incorporated on October 9, 1910 as the "Woman's Improvement Club of Jackson" with the purpose of advancing the City of Jackson in the County of Amador, State of California along the lines of Civic, Social and Educational Improvement; and

WHEREAS, the initial goals of the Club were to establish a high school in Jackson (dedicated June 19, 1913) and maintain the beautification of this school's grounds; and

WHEREAS, in 1917, the Club reincorporated as the Woman's Club of Jackson, was awarded a donation for its community support by Mr. W. F. Detert to purchase the Constitution Saloon and borrowed monies to create a suitable meeting establishment; and

WHEREAS, in 1917, with the United States inclusion in World War One, the ladies of the Club concentrated their energies on rolling bandages, knitting garments, and preparing packages for the troops abroad; and

WHEREAS, on January 1, 1921, the first free county lending library opened rent free in the Woman's Club building since the Club encouraged the county to provide such a facility; and

WHEREAS, the Club efforts to create a city park were successful in the establishment of Detert Park which included their donation of playground equipment in 1939; and

WHEREAS, from 1942-1945, the club supported the war effort by purchasing war bonds and providing the clubhouse for use by the Red Cross, and the Junior Red Cross; and

WHEREAS, when a scout hut was constructed at the city park in 1944, the Jackson Woman's Club provided funding for the fireplace and chimney; and

WHEREAS, the Jackson Woman's Club annually contributes to several local organizations which includes but is not limited to: Amador STARS Cancer Fund; Sutter Amador Hospital; 4-H Guide Dogs; American Legion Ambulance Fund; Amador County Senior Center; Friends of the Library; Volcano Community Building Fund; and Christmas to Remember; and

WHEREAS, as it celebrates its centennial year, the Jackson Woman's Club continues its commitment to advance the City of Jackson in the County of Amador, in the State of California.

NOW, THEREFORE, BE IT RESOLVED, that the Amador County Board of Supervisors does hereby honor and congratulate the Woman's Club of Jackson in celebrating 100 years of philanthropic service to the community of Jackson.

The foregoing resolution was duly passed and adopted by the Board of Supervisors of the County of Amador at a regular meeting thereof, held on the 14th day of September 2010, by the following vote:
