Good morning Chuck - EID is pursuing Department of Energy grant funding for the Silver Lake Dam Replacement project and we were hoping that Amador County would provide a letter of support for our application. Silver Lake Dam was constructed in 1876 and is critically important to EID's supply reliability and hydroelectric output. Several operational and dam safety deficiencies have been identified and EID's alternative analysis, coordinated with the Federal Energy Regulatory Commission and the CA Department of Safety of Dams, indicates that complete dam replacement is the best option to improve dam safety. The Project will mitigate the identified dam safety deficiencies and enhance operational reliability, reducing potential for loss of life, property damage, and economic and social-environmental impacts.

The project includes demolition and removal of all existing structures, construction of a replacement roller compacted concrete (RCC) dam with a central overflow spillway, a new 48-inch low-level outlet conduit and 60-inch auxiliary outlet, a vehicular bridge over the spillway, and a parapet wall for additional freeboard. The project is scheduled for construction in 2027.

The cost of the project is estimated to be \$40 million, so the \$5 million available through the DOE grant program would help reduce the cost to our ratepayers. The grant application deadline is October 6, 2023 so if possible we would need the letter a few days before that. Would the letter of support need to be approved by the Board of Supervisors? Let me know if you would be willing to provide one and we will transmit a draft letter for your review.
