**Environmental Health:** Update on the microenterprise home kitchen operations (MEHKO) pilot program and options on renewal.

Ms. Debra Larson, Environmental Health Director, addressed the Board and summarized the staff report relative to this matter, which is hereby incorporated into these minutes as though set forth in full. In summary, Ms. Larson stated the MEHKO pilot program is ending and Environmental Health is seeking direction from the board on whether to cease the program, expand, or continue it as is. Chairman Brown asked if there'd been any complaints and Ms. Larson said no complaints have been received, however, there is one operator that has a violation for not testing their well water, which they're working on resolving.

Mr. Gregory Gillott, County Counsel, announced they would bring back an amendment to this ordinance to expand to four operators and expand the term.

Lengthy discussion ensued with the following action being taken.

<u>ACTION</u>: Direction given to staff to authorize up to four MEHKO permits per year and expand it until December 2024.

**Code Enforcement:** Discussion and possible action relative to adding the re-establishment of the countywide abandoned vehicle abatement fee of \$1.00 per registered vehicle to the March Presidential Primary OR the November 2024 ballot.

Mr. Gregory Gillott, County Counsel, addressed the board stating this item needs clarification on whether the board prefers to set this on the primary or general election ballot for 2024. Mr. Gillott mentioned the resolution previously passed will be edited and placed on consent at the next scheduled board meeting to reflect November 2024 as the designated date for the measure to be added to the ballot.

In summary, Mr. Gardner and Ms. Pitto said they're requesting a resolution be passed to include in their second round SB 1383 grant application. Ms. Pitto noted the grant program provides funding to local jurisdictions to assist with the implementation of regulation requirements associated with SB 1383. Ms. Pitto said this includes capacity planning, education and outreach, enforcement and inspection and that the new SB 1383 Local Assistance Grant Funds will be used to continue to implement SB 1383 requirements throughout the Cities and the County of Amador.
