WHEREAS, According to the Centers for Disease Control and National Weather Service, extreme temperatures could lead to weather related illnesses, including heat strokes, dizziness, heat exhaustion, hypothermia, frostbite, long term health conditions, and loss of life; and

WHEREAS, As the community continues to be affected by extreme weather events, the County needs to have an operational policy to ensure efficiency and consistency related to the opening of a Warming or Cooling Center going forward in response to extreme weather events; and

WHEREAS, Warming and Cooling Centers are meant to be a short-term solution to a temporary problem that arises when the region experiences severe weather, and to provide temporary shelter to those who are most vulnerable to these severe weather events ; and

WHEREAS, Pursuant to California Government Code § 8593.3, the County is required to incorporate a Transportation Plan in its emergency plan in order to serve persons with access and functional needs when a warming or cooling center is opened; and

WHEREAS, Amador Transit has entered into a Memorandum of Understanding with the Amador County Sheriff's Office of Emergency Services in order to provide transportation for those persons with access and functional needs when a warming or cooling center is opened; and

THEREFORE, BE IT HEREBY RESOLVED that the Board of Supervisors of the County of Amador, State of California, does hereby approve the Amador County Warming and Cooling Centers Operations Guide; and

BE IT FURTHER RESOLVED, that the Chairman of said Board be and hereby is authorized to sign the Memorandum of Understanding between Amador Transit and the Amador County Sheriff's Office of Emergency Services.
