Administrative Agency: Discussion and possible action relative to a Public Hearing to consider an Appeal of the County's determination that the grading and encroachment permit applications to construct a public roadway for appellant's 281-unit residential project, Lake Camanche Village Unit 3B, are incomplete. The County deemed the applications incomplete because the applicant failed to provide information the County requested to evaluate environmental impacts under the California Environmental Quality Act. The applicant contends the County cannot request information that is not specifically listed on the County's application checklist.

Mr. Bradley Johnson, Attorney for Petitioner and Plaintiff, presented the Petitioners opposition to the Demurrer filed by Amador County relative to this matter and is hereby incorporated into these minutes as though set forth in full.

Mr. Glenn Spitzer, Deputy County Counsel, addressed the Board and answered questions specific, but not limited to, the Petitioners interpretation of the Permit Streamlining Act (PSA) and California Environmental Quality Act (CEQA) as it relates to requiring agencies to request information necessary to perform environmental analysis.

Mr. Mark Hopkins, Amador County Transportation and Public Works, Project Manager, also provided input relative to this matter.
