PROJECT NAME AND DESCRIPTION: Zone Change (ZC-24;7-1 Lyman) from the R1A, Single-family Residential and Agriculture zoning district to the AG, Exclusive Agriculture zoning district for approximately ±174.25 acres with the inclusion of that same property in a California Land Conservation Act (CLCA) AKA Williamson Act Contract. APNs: 044-010-091, -092, -093, -096.

Location: North of Jackson Gate Rd., between Jackson City Limits and Depot Rd. in Martell, CA

ENVIRONMENTAL REVIEW PROCESS: In accordance with the California Environmental Quality Act (CEQA), the lead agency, the Amador County Planning Commission, intends to consider the project exempt from CEQA. The project is consistent with the Amador County General Plan and zoning codes. The environmental assessment and application materials appear to be complete and indicate there are no extraordinary or unique environmental issues not normally mitigated for with the County's standard conditions which would be applied to this type of project. If, during the processing of this application, it is determined that there are state or local issues which cannot be found to be insignificant or adequately mitigated through standard conditions, it may be found by the Planning Commission or Board of Supervisors an CEQA Initial Study shall be prepared. The Technical Advisory Committee (TAC) has reviewed this project and has found no technical objection to the approval of this project and finding the project Exempt under CEQA.


