DECLARATION AND ACKNOWLEDGEMENT

1. Area has been identified on the subject parcel which may be capable of supporting an alternative sewage disposal system design.
2. Proposals for alternative sewage disposal systems must be designed and certified by a California Registered Civil Engineer, Registered Environmental Health Specialist, or California Licensed Geologist knowledgeable in on-site sewage disposal.
3. The installation permit must be obtained within 90 days of approval of the alternative sewage disposal system design.
4. Inspections by the Environmental Health Department will be made as specified on the inspection schedule provided at permit issuance. The property owner, contractor or designated representative shall request and coordinate all inspections with the designer, as well as Environmental Health.
5. Any design changes must be certified by the designer and submitted to Environmental Health for review and approval prior to installation.
6. The designer must certify in writing that the alternative sewage disposal system was installed according to the approved plans. Material or equipment substitutions differing from the approved design shall be identified and expressly approved. Installation deviating from the design shall be supported by an as-built drawing. The designer shall certify that any equipment or controls have been adjusted and/or programmed in conformance with design specifications. This certification must be submitted to Environmental Health promptly after the final inspection by the designer. This certification is required prior to final approval of the disposal permit.
7. Monitoring of the alternative system, constructed under permit on the subject parcel, will be conducted by the Environmental Health Department for a minimum of five (5) years. County Service Area #6 was established for the purpose of collecting the monitoring fees as a direct charge on the property owner's property tax statement.

8. Per Amador County Resolution No. 93-411, the property owner and the County of Amador by and through the Amador County Environmental Health Department shall enter into an agreement that will be recorded with the Amador County Recorder prior to final approval notifying any and all future owners of the property that an alternative sewage disposal system has been installed on the subject parcel.

THE UNDERSIGNED MAKES THE FOLLOWING DECLARATION:

I am the owner of the subject property. I have read and understand the above conditions for issuing the alternative sewage disposal permit on the subject property. I declare that the approved alternative sewage disposal system for said parcel will be installed per plan and inspected by the contracted designer and the Environmental Health Department within twelve (12) months of the date permitted. THE PERMIT WILL EXPIRE AND BECOME VOID IF CONSTRUCTION OF THE SYSTEM AND INSPECTIONS HAVE NOT COMMENCED WITHIN THE ABOVE TIME PERIOD.
